

## **REQUIREMENTS FOR COMPLETION OF THE PGY-2 PHARMACOTHERAPY RESIDENCY PROGRAM**

### **REQUIREMENT FOR GRADUATION**

#### **Direct patient care rotation activities**

- Provide education to at least 200 patients by the end of residency
- Document at least 150 patient care activities in the electronic health record
- Complete 75 comprehensive medication managements with at least 50 being comprehensive medication reviews (CMR) in the outpatient electronic health record
- Complete required presentations per rotation syllabi
- Ensure PGY-2 disease state list is completed

#### **Hospital Pharmacy Practice**

- IV certification and fingertip assessment
- Calculation exam
- Complete 1 pharmacist and/or technician schedule for department and manage
- Verify approximately 75 orders per staffing session

#### **Complete 2 monographs for formulary review**

- Reviewed at formulary management
- Presented at Pharmacy and Therapeutics Committee

#### **Complete/Revise a policy / procedure for the pharmacy department**

#### **Complete a medication use evaluation (MUE) or evaluation of service/initiative**

- Proposal created with IRB approval
- Submit for presentation at the Midyear ASHP conference
- Submit for presentation Encore at the annual NJSHP conference
- Create poster
- Presented at Pharmacy and Therapeutics Committee and relevant committees as deemed appropriate

#### **Complete a longitudinal research project by end of residency**

- Complete CITI training
- Proposal created with IRB approval
- Present a poster or platform presentation at Eastern States Conference
- Presented at Pharmacy and Therapeutics Committee and relevant committees as deemed appropriate
- Submit for presentation (encore) as professional poster at Midyear ASHP conference and annual NJSHP conference
- A manuscript must be submitted prior to graduation

#### **Provide Presentations**

- 3 noon conferences to medical staff per residency year
- 2 to 3 Clinical pearls to pharmacy staff
- Create and present 2 didactic lectures (quiz and pharmacotherapy care plan) for the Women's Health elective at Rutgers University

#### **Service to Pharmacy Practice (see project list for details)**

- Complete all required learning experiences and weekend commitments to hospital practice
- Active member of appointed committees (complete minutes for two pharmacy and therapeutics committee, all medication management, formulary management and antibiotic stewardship meetings when assigned)
- Participate in local organizations monthly meetings (NJSHP)
- Complete all assignments on time

## **REQUIREMENTS FOR COMPLETION OF THE PGY-2 PHARMACOTHERAPY RESIDENCY PROGRAM**

### **Complete Teaching Learning Certificate program if not previously attained**

- Attend all sessions
- Create a syllabus and teaching philosophy
- Primary preceptor for APPE student for 1 rotation

### **Additional Residency Requirements**

- Maintain/Attain BLS and ACLS
- Successfully complete all department competencies as assigned
- Successfully complete all rotations (all goals and objectives must be marked as satisfactory progress” (SP) or “achieved” (ACH). If any areas are “needs improvement”, a plan will be developed with the resident, residency program director and preceptor to ensure SP or ACH is met either through longitudinal activities or assigned tasks documented to the quarterly customized plan.
- At least 80% of required educational goals and objectives must be achieved
